VIRTUAL MEETING

Meeting was called to order by the Chair at 7:00 p.m.

1.  - b) Jan noted that she had seen 24 different species of birds on the trail from Exit 20 to Salmon Run.
 - c) There was a discussion about hiring someone to work on the gardens, but there is a hiring freeze currently. Perhaps a request for volunteers would be helpful.

 - a) **Trail Advisory Committee:** Chuck reported on the recent Trail Advisory Committee meeting. It is hoped that the mile markers will be put in place this summer. There is still the issue of spraying unwanted vegetation that needs to be addressed.
 - b) Anonymous complaint re: Sunrise Shores: The Winnisquam Watershed network forwarded an anonymous complaint to the TCC, which was then forwarded to the Tilton Code Enforcement and Health Officers. The Health Officer sent the information to the Division of Regulatory Services at the Department of Agriculture. Jim did a site visit and there was a discussion about fresh cow manure as opposed to composted cow manure.
