April 18, 2022

MINUTES

Meeting was called to order by the Chair at 7:01 p.m.

1. **Minutes:** Bob made a **motion**, which was seconded by Ken, to accept the March 21, 2022 minutes. All were in favor.

 - a) **WRTA Trail Update** – Ken provided details about the planned brush-clearing and clean-up work along the Tilton portion of the trail starting at McDonalds on June 4 at 9:00. Trash will also be picked up at Salmon Run. There was a discussion about possible future plans for trail expansion. Both WRTA and the TCC are interested in adding new information to the kiosk, particularly about accessing the Northfield section of the trail.
